User Code of Ethics

Users must respect the privacy of any information that they have access to. This includes but is not limited to personal information such as ID numbers, contact information and current weight of a wrestler or his/her opponents; medical information of any kind.

It is highly unethical for a user to provide their login details to another party. Under no circumstances is any User allowed to provide access to any private and confidential information to another third party who does or does not have access to such information.

A User cannot act in any other manner which could possibly be construed as being unethical.

Any user suspected of acting contrary to the above will have their access to eTMS revoked pending a full investigation by the SAWF Executive and dealt with in line with the SAWF's Disciplinary Code and Grievance procedure.

Registering, Access to Site, Password, Username and Privacy

1. Prior to making use of the services available on the eTMS/eMMS site (the Site), you are required to provide the SAWF with personal information which may include without limitation, your name, id number, email address, physical address and age. The user must ensure that all the details provided are true and correct. The SAWF shall not be liable for any expenses, costs or damages incurred as a result of incorrect details. The SAWF assures its users that it respects their privacy and is committed to safeguarding their privacy online. The SAWF shall take all reasonable steps to protect the personal information of users and shall comply with the Protection of Personal Information Act ("POPI") in this regard
2. Once you have registered, you shall be provided with a username and password, as allocated to you by the SAWF. Such username and password shall be used to access the various protected areas of the Site, which are exclusive to the users of the site and the members of the SAWF. By accessing the Site, you warrant and represent to SAWF that you are legally entitled to use the services. Any person below the age of 18 (eighteen) years may not use the services and must be assisted by their legal guardian when reading and entering into these Terms.
3. On registering as a user, you agree and warrant that your username and password shall be used for your personal use or in the process of carrying out your duties as a member of the SAWF only and shall not be disclosed to any third party. You shall accordingly assume full responsibility for all activities on the Site undertaken through use of your username and password. In the event of any third party acquiring or having unauthorised use of your username or password, you shall notify the SAWF immediately. You shall thereafter refrain from making use of the Site's services until such time that a new username and password has been allocated to you by the SAWF.
4. You acknowledge and agree not to use any personal information provided on the Site for any other purpose other than what is needed to perform your duties as an authorised member of the SAWF. You also agree not to disclose any information relating to any person or member listed on the Site to any third party without the express written consent of the person whose information is being disclosed or any person who does not have the right to view or be in possession of such information.
5. Failure to comply with the above terms and conditions will result in your access being suspended pending an investigation and possible disciplinary procedures.

Confidentiality and non-disclosure

1. Any person(s)/Associations/Federations who use the eTMS/eMMS and each User within any of the Associations or Federation are bound by the various restrictions regarding personal information as directed by statute
2. By subscribing as a User of eTMS/eMMS, you agree that you shall hold in the strictest confidence and not disclose to any third-party information acquired in connection with any aspect of the services, save where such information is disclosed in accordance with the legitimate intent and purpose of the services available on the Site. This includes but is not limited to:
 - 2.1. Any member's personal information that is recorded on the site
 - 2.2. Any wrestler's age, weight, medical information or history which is not already publicly available
 - 2.3. Any member's electronic copy of his/her ID, Birth Certificate, Passport, Police Clearance Certificate or any other document which may be required to successfully register as a member of the SAWF.
 - 2.4. Any member's grading, examination or practical evaluation result.
3. You must notify the SAWF immediately should you discover any loss or unauthorised disclosure of the information.
4. The requirements for confidentiality and non-disclosure will apply:
 - 4.1. During the period of your involvement on any committee, council or management structure within the SAWF
 - 4.2. If you are no longer involved in any committee, council or management structure within the SAWF.

4.3. If you are no longer involved in any committee, council or management structure within the SAWF and even if you have has ended your membership with the SAWF.
