

WEBSITE PRIVACY POLICY

The South African Wrestling Federation ("SAWF") believe in using data obtained via our digital platforms in a way which is fair and transparent.

1 SITE TERMS AND CONDITIONS

1.1 These Terms and Conditions ("Terms and Conditions") govern your ("User") use of the SAWF ("SAWF") website located at the domain name www.wrestling.org.za ("Website") as well as the electronic member and tournament management system ordinarily employed by the SAWF located at the domain name etms.wrestling.org.za ("eTMS"). By accessing and using the Website and/or eTMS, the User agrees to be bound by the Terms and Conditions set out in this legal notice. The User may not access, display, use, download, and/or otherwise copy or distribute Content obtained on the Website and/or eTMS for marketing and other purposes without the consent of the SAWF.

2 ELECTRONIC COMMUNICATIONS

2.1 By using this Website and/or eTMS or communicating with the SAWF by electronic means, the user consents and acknowledges that any and all agreements, notices, disclosures, or any other communication satisfies any legal requirement, including but not limited to the requirement that such communications should be in writing.

3 COOKIES

3.1 What is a cookie?

3.1.1 A cookie is a basic text file that is stored on your device (computer, mobile phone, tablet or other) by a website's server. Each cookie is unique to your web browser and contains completely anonymous information such as a unique identifier and the website name. This allows a website to remember things like your personal preferences, products you prefer or what's in your shopping basket.

3.2 Why do we use cookies?

3.2.1 The Website and/or eTMS may utilise first and third-party cookies. This enables us to:

3.2.1.1 Improve the User's experience on our Website and/or eTMS through various means such as storing preferences (like keeping a User logged in) or determining aggregate usage behaviour (time on site, number of pages viewed etc.) through web analytics tools like Google Analytics.

3.2.1.2 Provide more relevant Display Advertising to Users who have visited the Website and/or eTMS, using third party tools such as the Google Analytics Remarketing.

3.3 Cookie Opt out

3.3.1 Most web browsers provide the option to block some, or all cookie types should you wish to. Users can also opt out of the Google Display Network using the Ads Preferences Manager. Because many of our Website and/or eTMS's features may utilise cookies, we recommend that Users do not block them.

4 UPDATING OF THESE TERMS AND CONDITIONS

4.1 The SAWF reserves the right to change, modify, add to, or remove from portions or the whole of these Terms and Conditions from time to time. Changes to these Terms and Conditions will become effective upon such changes being posted to the Website and/or eTMS. It is the User's obligation to periodically check these Terms and Conditions at the Website and/or eTMS for changes or updates. The User's continued use of the Website and/or eTMS following the posting of changes or updates will be considered notice of the User's acceptance to abide by and be bound by these Terms and Conditions, including such changes or updates.

5 COPYRIGHT AND INTELLECTUAL PROPERTY RIGHTS

- 6.2 This Website and/or eTMS and the Content may not be reproduced, duplicated, copied, resold, visited or otherwise exploited for any commercial purpose without the express prior written consent of the SAWF. The license does not allow the User to collect website content, product or service listings, descriptions or other information displayed here, and does not allow any derivative use of this Website and/or eTMS or the Content for the benefit of another person/group/entity.
